-REMARKS BY SENATOR EDMUND S. MUSKIE BEFORE THE FLORIDA CABINET, 27 APRIL 1971

IN MAINE WE HAVE TWO SEASONS -- JULY AND WINTER.

IN FLORIDA YOU HAVE THE SAME, WITH A DIFFERENCE. IN

MAINE, ACCORDING TO SOME WAGS, OUR JULY LASTS ONE DAY

AND WINTER 364. IN FLORIDA YOUR WINTER IS ONE DAY, WITH

JULY TAKING UP THE REST OF THE YEAR.

BOTH STATES FACE PROBLEMS PRESENT THROUGHOUT AMERICA:
CITIES AND RURAL AREAS, SMALL TOWNS AND BIG CITIES, TRYING
TO SURVIVE POPULATION SHIFTS; AGRICUTLTURE AND INDUSTRY
TRYING TO COPE WITH ENVIRONMENTAL PROBLEMS AND ECONOMIC
DEADLINES.

WE HAVE UNEMPLOYMENT ALONGSIDE SKILLED MANPOWER
SHORTAGES, AND HIGH TAXES BUT REVENUES INADEQUATE TO PROVIDE
ESSENTIAL PUBLIC SERVICES.

THESE ARE PROBLEMS IN FLORIDA AND IN MAINE. THEY ARE PROBLEMS IN THE OTHER FORTY-EIGHT STATES.

BUT OUR STATES ARE DIFFERENT FROM MANY OTHERS IN THEIR
RELIANCE ON THEIR NATURAL ENVIRONMENTS FOR MUCH OF THEIR
ECONOMIC WELL-BEING. BOTH ATTRACT VISITORS AND NEW RESIDENTS,
AND KEEP THEIR OWN, BECAUSE OF SURROUNDINGS WHICH MAKE OUR
STATES MORE THAN PLACES TO EXIST. BOTH STATES ARE WORKING
VERY HARD TO IMPROVE THE QUALITY OF THEIR ENVIRONMENTS.

THE CONGRESS HAS PASSED A NUMBER OF LAWS TO ASSIST THOSE EFFORTS. THIS YOU KNOW.

IN THIS SESSION OF CONGRESS WE ARE WORKING TO EXPAND EXISTING AUTHORITIES FOR AIR AND WATER POLLUTION CONTROL AND SOLID WASTE MANAGEMENT. OUR MAJOR EMPHASIS, THIS YEAR, IS ON DESIGNING WATER POLLUTION AND OCEAN DUMPING LEGISLATION TO GIVE THE STATE'S A REAL CHANCE TO USE THEIR CAPABILITIES TO CLEAN UP OUR WATERWAYS AND SHORELINES. OTHER LEGISLATION INCLUDES RESOURCE MANAGEMENT AND UTILIZATION POLICIES, PACKAGING, DETERGENTS, AND LAND-USE POLICIES.

WE CANNOT IMPROVE ENVIRONMENTAL QUALITY WITHOUT THE COOPERATION OF ALL LEVELS OF GOVERNMENT, THE EFFORTS OF INDIVIDUAL CITIZENS AND INVESTMENTS BY THE BUSINESS SECTOR. IN MANY PARTS OF THE COUNTRY WE NEED THE KIND OF COMMITMENT TO ENVIRONMENTAL QUALITY WHICH THE STATE OF FLORIDA AND ITS PEOPLE HAVE MADE.

YOU HAVE MADE REAL PROGRESS. YOUR LAWS TO PROTECT
YOUR COAST FROM OIL SPILLE AND YOUR OPPOSITION TO WASTE
DUMPING IN THE OCEAN ARE EVIDENCE OF YOUR COMMITMENT.

I AM SURE YOU AGREE WITH ME, HOWEVER, THAT MUCH MORE

MAY HAVE TO BE DONE TO PROTECT THE ENVIRONMENT. WE MAY

HAVE TO TAKE STRONG STEPS TO REDUCE MORDD VEHICLE CONCENTRATIONS

IN OUR URBAN AREAS. WE MAY HAVE TO REQUIRE CLOSED CYCLE WASTE

TREATMENT SYSTEMS AND WATER REUSE FOR INDUSTRIES AND COMMUNITIES,

TO REDUCE EXCESSIVE DEMANDS ON OUR FRESH WATER SUPPLIES.

WE MAY HAVE TO INSTITUTE MUCH MORE STRINGENT LAND-USE POLICIES,

TO INSURE AGAINST LAND ABUSE AND OVER-CROWDING.

THE ISSUE IS NOT WHETHER WE SHALL HAVE A HEALTHY ECONOMY OR A HEALTHY ENVIRONMENT, BUT HOW WE CAN PLAN TO INSURE BOTH.

ACROSS AMERICA TOO MANY AREAS HAVE BEEN PLUNDERED.

TOO MANY RECREATION AREAS HAVE BEEN RAVAGED BY UNPLANNED

COMMERCIAL DEVELOPMENT. TOO MANY BEACHES AND WOODLANDS,

MOUNTAIN AREAS ANDLANKES, RIVERS AND PLAINS AREAS HAVE

BEEN OVER-DEVELOPED FOR SHORT TERM ECONOMIC GAINS. THE

RESULTS HAVE BEEN LONG TERM ENVIRONMENTAL DEGRADATION

AND ECONOMIC LOSSES.

I REGARD THE DEVELOPMENT OF POLICIES FOR BALANCED

GROWTH AND ENVIRONMENTAL PROTECTION ONE OF THE GREAT

CHALLENGES OF THE SEVENTIES. IT WILL NOT BE CHEAP OR

EASY. BUT THE EFFECT OF A DYNAMIC, PEOPLE—ORIENTED BALANCED

GROWTH PROGRAM IN YOUR STATE, AND IN MINE, CAN HAVE VERY

IMPORTANT RESULTS: THE STATE WILL DIRECT ITS OWN DESTINY;

THE COUNTRY WILL BENEFIT FOR GENERATIONS FROM SUCH FORESIGHTEDNESS;

AND VITAL NATIONAL RESOURCES WILL BE MAINTAINED AND ENHANCED.

I BELIEVE THESE BENEFITS ARE WORTHY OF YOUR BEST

LEGISLATIVE EFFORT; AND I ASSURE YOU THAT WE SHALL DO EVERYTHING

WE CAN TO HELP.
