MUSKIE ANNOUNCES SERVICE ACADEMY APPOINTMENTS

Senator Edmund S. Muskie (D-Maine) announced today six appointments of young men from Maine to the class of 1975 at the United States military academies.

Two appointments each were made to the U.S. Military Academy at West Point and the U.S. Air Force Academy while one appointment was made at the U.S. Naval Academy and the U.S. Merchant Marine Academy at Kings Point.

The Senator said that he submits a list of the nominees for appointment to each of the academies after careful consideration of all applications to his office from the state. The service academies themselves make the final selections from the list submitted.

"The young men appointed by the academies represent the finest traditions of scholarship, leadership, and character. They are a source of pride to their families, their schools, their communities, and the state," the Senator said.

In letters to each of the students, Senator Muskie wrote, "I want you to know how pleased I am that you have been selected as my principal appointment to the Class of 1975.

'The next four years will be among the most demanding of your life, and I sincerely hope that they prove to be the most rewarding.

"The Academy traditionally keeps Members of Congress advised of the progress of the coung men they have appointed, and I am looking forward to following your career."
